The Bosnia and Herzegovina (hereinafter called "Borrower") has received financing from the International Bank for Reconstruction and Development (IBRD) and European Investment Bank (EIB) (the "Banks") in the form of a credit (hereinafter called credit toward the cost of Federation Road Sector Modernization Project. The JP Ceste Federacije BiH, an implementing agency of the Client, intends to apply a portion of the proceeds of this credit to eligible payments under the contract for which this Request for Proposals is issued. Payments by the Bank will be made only at the request of the Client and upon approval by the Bank, and will be subject, in all respects, to the terms and conditions of the loan agreement. The loan agreement prohibits a withdrawal from the credit account for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import, to the knowledge of the Bank, is prohibited by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations. No party other than the Client shall derive any rights from the loan agreement or have any claims to the proceeds of the credit.

The Client now invites proposals to provide the following consulting services (hereinafter called "Services"): IRAP Survey of the Road Network. More details on the Services are provided in the Terms of Reference (Section 7).

A firm will be selected under Least Cost Selection (LCS) procedures and in a Full Technical Proposal (FTP) format as described in this RFP, in accordance with the policies of the Bank detailed in the Consultants' Guidelines which can be found at the following website: www.worldbank.org/procure.

Anticipated period of services will be: 5 calendar months.
